### FINANCIAL/PAYMENT POLICY

#### Regarding Insurance Coverage

New Day does not accept any insurance plans for payment of services. This decision has been made as we feel that is best serves the individuals to whom we provide services. In the past New Day did accept insurances plans; however the level of control insurances place on treatment and the cumbersome processes required are a detriment to the treatment/assessment process. As such, we no longer accept any insurance coverage.

#### Payment Accepted

New Day accepts payments in cash, check, or credit/debit card (Visa, MasterCard, and Discover). There is a 3% processing fee for credit/debit cards to cover our cost of using this method. If a check is used, reports etc. will not be released until the check clears the bank. Any checks returned for insufficient funds will be charged a 35.00 fee and all future payment will be required in cash or credit/debit cards.

#### Payment Schedule

When an appointment time is scheduled with New Day an estimate of the fee required will be provided. This is estimated as the type of testing required will not be fully determined until the appointment and initial assessment have occurred.

For clients who will require psychological testing, at the time of the initial appointment 50% of the estimated fee is due. A final fee will be provided at the time of the initial assessment. The balance of the fee will be due at the final/review session. Reports will not be released until payment is made in full.

For clients seeking only a clinical interview (no psychological testing) the full fee is due at the time of the interview appointment. This will also be the case for those seeking counseling/therapy services.

**Payments based on Financial Need**

It is the general policy of New Day to not turn people away based on ability to pay. As such, we make every effort to make our fees reasonable and affordable. A standard fee schedule is established and these rates are shared at the time an appointment is established.

For those who demonstrate financial need, we will offer discounts to our fees. This discount will not exceed 50%. The amount of discount is determined by demonstrated financial need. Those who would like to be considered for a discount will be required to provide their income tax return from the most recent year. We will only need to know the NUMBER OF DEPENDENTS claimed and the NET family income for the year.

New Day also provides pro bono (free) services for those in significant need e.g. services provided at no fee. Such requests will be considered on a case by case basis.
